Terms and conditions

1. ResMed Asia Pacific ABN 86 070 076 470 of 1 Elizabeth Macarthur Drive, Bella Vista NSW 2153 (**ResMed sleepvantage**) offers a 14 Day Money Back Guarantee to patients who are not completely satisfied with their new AirFit series mask purchased from a ResMed Authorised Dealer between 13 November 2018 and 31 December 2020, subject to these terms and conditions (**Offer**).
2. Under the Offer, if a patient who purchases one of the AirFit masks set out in Clause 3 from a ResMed Authorised Dealer is not completely satisfied with the mask, they may return it to the ResMed Authorised Dealer where they purchased the mask, at their expense, for a full refund to the value of the original cost of the returned mask, provided:
 - a) the AirFit mask is returned within 14 days of purchase;
 - b) the AirFit mask has been fitted by a CPAP Clinician/Specialist;
 - c) the patient has provided the ResMed Authorised Dealer with proof of purchase for the returned AirFit mask; and
 - d) the patient is a member of ResMed sleepvantage.
